## 7. OPEN DISCUSSION

#### A. MALDEN YMCA – UPDATE

The Executive Director and Attorney Callaghan informed the Board of the current status of the conveyance of the condominium units from the Malden YMCA to MHA. The Malden YMCA is hoping to obtain approval for tax-exempt financing to buy out MHA's condominiums once the condominium is conveyed. Bond counsel has requested additional information from MHA, but thus far bond counsel's opinion has been pessimistic as to eligibility for tax-exempt financing. MHA expects to transmit any relevant information by week's end. East Boston Savings Bank has provided a commitment letter to the Malden YMCA at a reasonable interest rate to provide conventional financing for the buyout, if tax-exempt financing is unavailable.
